Request for quotation (RFQ) for Desktop PC for the bank

1.1 Scope of Bid

Shahjalal Islami Bank (Hereinafter referred to as “the **Bank**”) willing to receive bids from the renowned firms for purchasing of Desktop Personal Computer (PC) for the period of minimum 01(one) year, which will be installed at different locations across the country.

1.2 Documents comprising the bid

1. Valid and up dated Trade License
2. e-TIN and VAT Certificate
3. Lease agreement / ownership title of office and full contact number of representative.
4. Company Profile (Establishment date, no of engineers, no of employees, no of bank clients, etc.)
5. Proof of Experience.
6. List of corporate clients with Certificates.
7. List of experience technical members.
8. Certificate of Authorized Dealer/ Supplier from the Manufacturer.
9. Original Catalogue with a mark/signature on respective items.

1.3 Bid prices

Bidders shall quote the price in Bangladeshi Taka (BDT) for the items quoted excluding VAT & including Tax (VAT to be borne by the Bank). The price will include supply, installation and any charges thereof.

1.4 Bid validity

Bid shall remain valid for a period of 3(three) months from the date of opening of proposals. In exceptional circumstances, prior to expiry of the original bid validity period, Bank may request the bidder to extend the period of validity for a specified additional period. The request and the responses thereto shall be made in writing. A bidder agreeing to the request will not be permitted to modify its bid.

1.5 Deadline of bid

The bidder must submit their bid in a sealed envelope addressed to: “The SVP & Head of CSD, Shahjalal Islami Bank PLC., Corporate Head Office, 2nd Floor, Shahjalal Islami Bank Tower, Plot-04, Block-CWN(C), Gulshan Avenue, Gulshan, Dhaka-1212”. The envelope must be clearly marked as: “Quotation for Personal Computer (PC)”. Both the **Financial Offer** and the **Technical Offer** must be provided separately in individual sealed envelopes within the main envelope, and each should be duly marked accordingly. Bid must be submitted no later than 2:00 PM on August 10, 2025.

1.6 Mode of Payment

Payment will be made after successful installation in all respects and subsequent submission of the bill after deducting Tax as per government rules. No advance payment will be allowed.

1.7 Security Money

5% of the final bill amount will be deducted from the bill and kept as Security money up to warranty period.

1.8 Mode of delivery

Supplier bound to deliver the product at site own arrangement and own cost within 15 days after receiving work order.

1.9 Warranty

Bidders/vendors should specify the warranty type and period clearly for each of the items /components. But the warranty period must not be less than 03 (three) year.


Bank has the right to negotiate price, warranty as well as terms and conditions with the lowest bidder and/or all bidders.
